Item 2 Discussion:

Code of Conducts

David: some further information has been circulated by Ross today, suggest that we take on board the recommendations and read with the suggested changes to the Code of Conducts which has already been circulated for discussion. To date there has been no feedback from EC.

- The rehoming of ex breeding cats to be included in the Breeders code. Also need to include consequences for non-compliance which could include termination of membership.
- Concern expressed about threatening of our members
- Clear information is what is required we have rules but there are no consequences when rules are breeched that is what is lacking
- Refer General Rules & Policies 2.27 relating to cessation of membership this should be included in the Constitution
- This was a restricted agenda that went to EC members only, so the membership has not at the time had the opportunity to discuss any of the recommendations. The membership will be asked to read and make further submissions relating to the code of conducts this is purely a discussion at this point in time

Social Media Policy The putting together of a policy will be addressed especially now with the increased postings on Facebook focusing on cats wins and details of cats being entered at shows - it is likely that the Show Bylaws will include a policy.

(a) Codes of Conducts:

1. Members Code of Conduct - refer page 2

NZCF members who do not adhere to the provisions of this code of conduct (other than the recommendations section) <u>may be subject to NZCF disciplinary</u> <u>procedures, including nonacceptance of membership applications **OR suspension** <u>until asked requirements are met.</u></u>

2. NZCF Breeders Code of Conduct – refer page 3 "In addition, the NZCF recommends.....

NZCF Breeders who do not adhere to the provisions of this code of conduct (other than the recommendations section) may be subject to NZCF Disciplinary procedures, including non-renewal of membership <u>OR suspension until asked</u> requirements of the breeders are fully met.

3. 2019 Membership Application Form: declaration amendment

The New Zealand Cat Fancy Inc. (NZCF) is bound by the provisions of the Privacy Act. Personal information collected by the NZCF will only be used for purposes essential to conduct the business of the NZCF and will not be divulged to a third party unless authorised by the person providing the information. EXCEPTIONS: I/We understand that the NZCF may, when requested, confirm whether or not I/We have current financial membership of the NZCF. I/We understand that the NZCF may share information with other registries where there are proven concerns relating to the safety or health of cats or kittens in my care. I/We consent to be bound by and submit to the Constitution, Disputes & Discipline Procedures, By-Laws, Rules and Codes of Conduct of the NZCF <u>and accept that failing to do so</u> <u>could lead to being disciplined OR membership being suspended.</u> I/We confirm that the NZCF club indicated above has my permission to confirm my membership of that club to the NZCF Secretary

4. Judges Code of Conduct

<u>NZCF</u> Judges who do not adhere to the provisions of this code of conduct <u>may be subject to NZCF</u> Disciplinary procedures, including non-renewal of <u>membership OR suspension of your Judges Licence until asked requirements</u> <u>are fully met.</u>

5. Judges Annual Return

Declaration: to read Judges not providing a return and undertaking to abide by the Judges Code of Conduct and completing all relevant NZCF Health & Safety requirements, <u>and accept failing to do so could lead to being disciplined OR</u> <u>my Judges License being suspended</u>. (<u>You will not</u> be included on Judges List circulated to Clubs and published on the NZCF website)

(d) Any Other Matters

Change of Colour	Jo reported that an exhibit had been shown at CABCC show that was clearly the incorrect colour entered as a Tortie and it is a Tortie bi-colour. This will be followed up with the owner and registrar to ensure that the appropriate changes are completed. The challenges (8) that have been issued will of course be withdrawn.
Complaints at Shows	Further discussion regarding the appointment of show Representative's to ensure that complaints can be dealt with in a timely manner on the day. This also needs to be included as part of the governance documentation.
National Show 2019	Concern expressed by several EC members who had Attended the CABCC show that people are not happy with a one ring National Show probably because they simply don't know how it is going to be run. Information needs to be released. Chris confirmed that the host club Patches & Pointed have set up a new website and have secured sponsorship and it is their intention to publish newsletters to keep members well informed – there have already been two newsletters released – perhaps it would be appropriate for the EC to give approval for the host to

issue updates on the membership forum and the NZCF website.

David/Sheree: That the host Club Patches & Pointed Inc. are given approval to utilise the membership forum and NZCF website to keep the membership up to date regarding the format for the 2019 national show. AND that the intention to appoint an NZCF judge (returning from leave of absence David Scadden) is approved." Carried
