DOMESTIC & COMPANION CATS DEFINITIONS

Longhair has a coat of MORE than 3cm long (approx 1 inch) and stands out from its body when brushed forwards. Hair on tail may stand out like a plume.

Shorthair is not easily brushed forward, may be flat and sleek or dense but not flowing. **Please Note:**

A cat or kitten entered in the Domestic Section of a Show, which has some known pedigree, or when benched, has a phenotype or appearance of any pedigree cat, will be transferred from the Domestic Section to the Registered Companion Cat Section of that Show by the Show Secretary and/or the Show Manager in consultation with the exhibitor/owner, or agent, with the registration number shown in the marked catalogue as "pending".

DOMESTIC & COMPANION CATS ENTRY ELIGIBILITY

- 1) All Companion & Domestic cats or kittens must be desexed (neutered or spayed)
- 2) Kittens must hold a current vaccination certificate with the most recent vaccination being dated at least seven (7) days prior to the show. Please ensure you have your current vaccination certificate with you.
- 3) Exhibits entering the Companion Cats Section must meet the criteria of Rule 6 of the NZCF Registered Companion Cats Section and not have been awarded an NZCF title above Champion or Premier as an NZCF registered exhibit (unless dispensation has been given by the Executive Council). If unsure whether your cat/kitten is eligible to be shown in the Registered Companion Cat section, please contact the Show Secretary for guidance.

Paul Henry – (NZCF Senior LH & Junior Shorthair Judge) Ring 3

I started in the cat world breeding Birmans with my late partner, Brian Smyth. In 1985 we got our Prefix "PREFERENCE" and breed the first 2 Birmans to become Double Grand Champions in NZ. Was so exciting as they were half-sisters from our foundation queen from her first 2 litters. They achieved this title just a week apart. Dbl Gr Ch Preference Lady Arabella, owned by J

& J Davey, "Leegrgo" and Dbl Gr Ch Preference Lady Bodicea. Owned by A & M Hart "Highbeech". We had quite a bit of success with and Blue point Birmans with a few going over to Australia.

I was also President of the Birman cat club for a few years and held office of show secretary for many years. With Brian's passing [nearly 24 years ago] I took on the Prefix and moved to Tabby point Birmans with my new partner Colin. I had just become a Longhair judge at this stage. I went on to breed the Top winning kitten in NZ in 1999 with Preference Fashion Hint, a Seal Tabby point Birman. At this time we branched out and bred and showed a few Persians and Exotics for a couple of years.

Also at this time I went into the Dog showing world, breeding and showing Shihzhu's. My first litter produced a male, whom I kept and showed until I retired him at 7 years old. He was the top winning Shihzhu in NZ just about all of that period of time. Becoming the 6th dog of this breed to become a Grand Champion in NZ.

I gave up the cats, breeding and judging in 2001 as I was burnt out and exhausted as was just all over the place with Dog shows and cat shows here and in Australia. I was asked by the Auckland Cat club to be their MC for their 50th Jubilee show in conjunction with the Nationals. By the end of that weekend I was back on the panel judging cats again. Now a few years later I am so glad I took that break as am thoroughly enjoying my judging again. By this time I had stopped breeding and showing my dogs.

I now have a new partner Tony, who used to own a Birman from Melissa Stevenson, a relation of his. So I have introduced him to the cat world of showing. We have 2 Maine Coon cats, one of which we have now retired as she doesn't like the show scene, but became a Double Grand Premier by the end of last year, 2016.

We are still showing the younger boy and having some good wins and fun with him. Tony is HOOKED! Last year I was badgered into doing my Shorthair school again, so I bit the bullet and am pleased to say that I am now on the junior panel for Shorthair section.

I will be half way through my assessment judging by the time this show is done. So proud of myself achieving this in such a terrible year for us. Firstly my Mum passing in March last year, then Tony's ex-wife passing in January this year and then my brother also passing on

the same date as Mum a year later. But I managed to do all my projects etc. as well. I also have been Emcee for quite a few of our National cat shows over the years and also on the Breakfast show and Seven Sharp for promoting Cat shows.

I really am enjoying this period of my life and enjoy judging very much, I try to tell the public what and how we judge cats when they are coming through. I have met lots of other cat lovers both here and in Australia as well as from further afield, and have become great friends with most of them.

I am so looking forward to this appointment. Thanks Paul
