**Mid Island Cat Club Awards:** Top Ten Pedigree Cats/Kittens. Neuter/Spay Pedigree Cats/kittens. Top companions and domestics. In Ring 1: Sponsored Prizes from Pet Direct and Bayer. Ring 2: Club Prizes. Ring 3: Club prizes. Ring 4: Cards. Special prizes allocated during the day. All Pedigree Exhibits receive one Rosette. Top Ten places are attached to Rosettes.

**Club Supreme Awards:** Points are awarded in each of the following Sections: Supreme Longhair (All Pedigree Longhair exhibits); Supreme Shorthair (All Pedigree Shorthair exhibits); Supreme Companion (All Companion exhibits); and Supreme Domestic (All Domestic exhibits) using the NZCF annual awards points calculator method.

**To qualify** for a Supreme Award each participating exhibit must have been awarded a Best in Show on the day.

**To win** any Supreme Award, the exhibit must have the most points accumulated from each of the rings entered and Top Ten place points won on the day. (Refer NZCF Show Bylaw 13.6 applies).

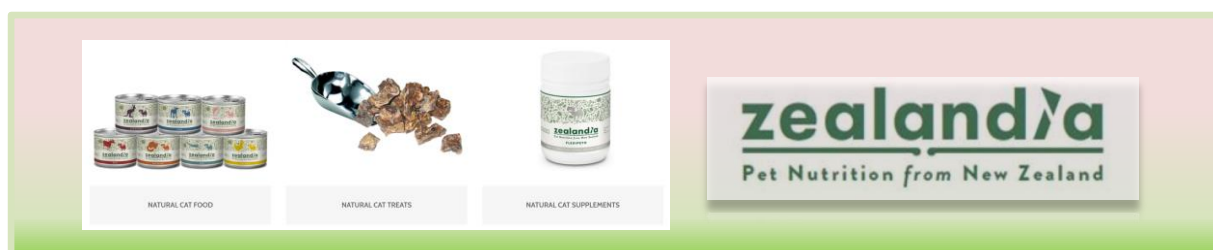

One Breeders Award of Merit will be offered in each pedigree longhair and shorthair divisions for both entire and neuter/spay cats and kittens.

**All Domestic and Companion exhibits must be de-sexed.**

### Special Notes for Exhibitors

1. If you are aged 16 years or less your entry form must be countersigned by a parent or guardian.
2. To win National Award points you must be a member of the NZ Cat Fancy Inc.
3. You bring to the Show:
  - Your exhibit's **Vaccination Certificate**.
  - Your exhibit in a secure ventilated box or carry cage.
  - Sufficient bedding to keep your exhibit warm and comfortable.
  - A plain towel for the judging table (*optional*).
  - A shoe box or plastic toilet/litter tray.
4. The Club will provide:
  - A standard sized wire show cage for your exhibit.
  - Sample litter for your exhibit's toilet tray.
5. All exhibits remain in their cage from start of Judging.
6. **If you want to leave the show early please fill in then attach your filled in form with your entry. Refer to NZCF Permission for Early departure form attached and on the NZCF website under Show By-Laws. Under the NZCF Show Rules the Club cannot accept early departure forms at the show.**
7. Please have cell phones on mute or off during judging.

### Exhibitor's Please Note

**Workers / Helpers on Show Day:** As with all shows we need workers - stewards, scribes, handlers, vet assistant, door keepers, meet and greet people. Please indicate, on your entry form, if you would like to work at the Show and in what capacity. The Show Secretary plans to notify all workers before the Show. If you are working on the Show Floor you will be required to wear a clean smock or apron supplied by the club.

**Helpers for setting up:** Help is needed on Friday, 22 May. We will start setting the cages up at 3.30 pm. Cages will be dismantled on Saturday evening. Helpers, please contact Show Manager prior to Friday, 22 May.

**Towels:** Exhibits may be presented to the judging table on **your towel**. **Your towel** must not have any distinguishing marks or other identifying objects to be placed on top of the cage during Judging. Cage bedding must not be used on judge's table.

**Feeding:** During judging it is best to remove all water and food containers from your exhibit's cage.

**Cage Curtains:** The Mid-Island Cat Club cages do not have solid walls; please bring your cage curtains if you have them. MICC cardboard dividers may be used if you do not have curtains. Cages are 61 cm (24 inches) wide by 54 cm (21 inches) high by 46 cm (18 inches) deep.

A PRIZE will be awarded for **Best Decorated cage**, theme this year is "1960 Pop Art". **Dress your cage for the part !!!**

**Influencing Judging:** Be mindful to avoid any attempt to identify yourself as the owner of a particular exhibit when speaking to the judges and their helpers until after judging has been completed. To do so may be regarded as attempting to influence the judging. **Good Sportsmanship:** Anyone, including children, behaving in an unseemly manner will be asked to leave the venue.

**Disputes:** Must first be raised formally in writing on **Show Day** by paying **\$50 to the Club delivered to our Show Secretary**. Your dispute will then be processed as required by the NZCF Show Rules applying.

### Venue Map

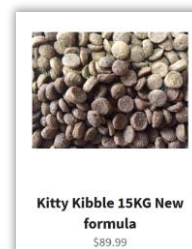

## GENERAL RULES AND CONDITIONS FOR ALL EXHIBITORS

**\*\* PLEASE READ CAREFULLY \*\***

1. This Show is held under the Rules and Bylaws of the New Zealand Cat Fancy Inc and the Mid-Island Cat Club Inc, and all exhibitors are deemed to have agreed to abide by such regulations.
2. The term 'cat' here includes any kitten. The term 'exhibit' refers to any cat or kitten. The term 'exhibitor' refers to any cat or kitten owner, or member of NZCF or a club member who has completed and had accepted application to enter their exhibit/s in our show.
3. The Show Committee reserves the right to amend prize lists or refuse any exhibit entry/s without giving any reason.
4. Exhibitors requiring receipts must send a stamped self-addressed envelope for return of receipt. All cheques are to be made payable to **"Mid-Island Cat Club Inc"**. Post-dated cheques, Money Orders or late entries will not be accepted.
5. Female pedigree cats that are obviously in kitten, or are lactating, entire pedigree male cats without both testicles palpable beyond the stomach wall, de-clawed or de-voiced cats or kittens, or cats/kittens with any body parts pierced for the purpose of applying an embellishment shall not be eligible for entry in any section.
6. Domestic and/or Companion exhibits must be de-sexed.
7. Prior to the show an application to with-draw any exhibit must be sent in writing to the Show Secretary advising the reasons to with-draw. For an application received before the close date for show entries a full fee refund will be considered. Any application to with-draw received after that date will result in forfeiture of part or all of the club entry fee, and all the benching fees payments due NZCF.
8. Exhibits must be brought to the Show in a secure container. Show Rules require that carry cages be left below exhibition cages in the hall to help with evacuation of exhibits in the event of an emergency.
9. **Pick up your cage number** and exhibitor passes from the Entry Clerk before exhibits are caged.
10. Exhibitors are responsible for their exhibits and placing them in their correct classes and cages. Only exhibits registered with the NZCF Inc. or those with prior approval are eligible to enter registered classes for this Show.
11. Every cat/kitten in a cage must have bedding. Any cat/kitten without bedding in its cage will not be judged. Bedding in a cage must not be used to put any exhibit on the judge's table. Keep out of the cage a separate plain un-marked towel for this purpose.
12. **Vaccination Certificates:** Vaccination certificates are required for **all** exhibits and must be presented to the Entry Clerk prior to benching – certificates must be at least 7 days old.
13. **All exhibits claws must be clipped prior to the Show.**
14. All exhibits must have **clean ears and coats free from ringworm, mange, fleas, etc.**
15. No exhibitor shall exhibit a cat which to their knowledge, at the date of the show, has been exposed to **ringworm** within the period of **90 days prior to the date of the show**, and no other cat may be exhibited if the exhibitor has had ringworm in their cattery or home during that period.
16. No exhibitor shall exhibit a cat which, at the date of the show, has been exposed to any **infectious or contagious illness** within the period of **21 days prior to the date of the show**, and no cat may be exhibited if the exhibitor has had any such illness in their cattery or home during that period. For Feline Infectious Peritonitis or Feline Leukaemia, the quarantine period shall be 90 days.
17. At least one qualified Veterinary Surgeon will be in attendance to examine each exhibit after benching. All exhibits entering the hall will be vetted, and once in the hall may not be removed without the permission of the Show Manager. If, in his opinion, any exhibit is not fit to remain at the Show, the exhibit/s shall be removed from competition and removed from the hall **immediately**. Other exhibits and the exhibitors may also be removed as the Veterinary Surgeon sees fit. The examining Veterinary Surgeon's decision shall be final.
18. Any exhibit presented at a NZCF Inc. show with a veterinary certificate (non-contagious) shall be thoroughly examined by the officiating Veterinary Surgeon. The examining Veterinary Surgeon's word is final.
19. It is **your** responsibility to present any certificate to the Veterinary Surgeon and then the Show Secretary. Certificates must be original (photocopies are not acceptable) and must include the date of examination. When your exhibit has been passed by the Veterinary Surgeon a mark will be put on your exhibits cage card.
20. Entry fees will be forfeited if an exhibit is declared unfit for exhibition upon examination by the Vet officiating at the show.
21. A copy of the Vet's rejection sheet shall be sent by the Show Secretary within 48 hours to the National Secretary, who shall notify any club holding a show within the isolation period that the owner and their exhibits shall **not** be eligible for exhibition and/or attendance at that show.
22. The Club will provide a standard sized cage and sample litter for your exhibit. Exhibitors to supply toilet trays and/or covered hot water bottles for their own exhibit. A coloured towel is permitted for use on the judging table. Clear plastic or Perspex cage fronts may be attached to the cage door only. Judges may bypass any cage where access to the cage is limited.
23. The Club reserves the right of admission, and persons behaving in an unseemly manner will be asked to leave the venue. Unsupervised, unruly children will be escorted from the Hall.
24. Aerosol sprays and litter other than the sponsors product must **not** be used in the Show Hall.
25. After vetting and once judging commences **no** exhibit may be removed from its cage other than by the Judge or by express permission of the Show Manager, except for handlers taking the exhibit to and from the Judges.
26. **No** exhibit may be removed from its cage or from the Show Hall before the close of the Show except at the discretion of the Show Manager. You must apply in writing (see form attached) to leave the show early and send that application in with your entry.
27. If entering a registered cat note **NZCF Show Bylaw 3.4(a): " Any registered cat exhibited at a Show held pursuant to these Show Bylaws shall be entered in the Show in the name of its breeder or the person or persons to whom it has been transferred or leased, prior to the date of the Show, as exhibitor."**
28. The Privacy Act requires your consent before we print the catalogue. Refer to the NZCF Show Rules for Privacy requirements.
29. No "For Sale" notices are permitted on cages. After judging is complete Breeders advertising, photos etc may be placed on cages.
30. The Club accepts no responsibility for loss or damage to exhibits or property but will endeavour to see that reasonable care is taken.

### Permission for Early Departure from a Show

In accordance with Show Bylaws, para 10.8:

Removal of an exhibit before the show has been officially closed without the prior permission of the Show Manager or Show Secretary will result in the loss of all club awards and NZCF annual awards points and any title points.

#### Planned early departures

Permission should be sought as soon as possible, and a minimum of 24 hours before the start of the show, using this form.

#### Emergency early departures

Require the permission of the Show Manager or Show Secretary and that should be recorded on this form.
