BARBARA LAROCCA – QFA Australia

Barbara grew up with a black and white domestic cat which came from a litter of kittens which her mother had rescued, after the mother cat had been shot with an air rifle. So began her love of cats. Barbara owned moggies until the early 1980's when she was introduced to, and instantly fell in love with the Burmese breed, and in 1984 she acquired her first breeding queen and began breeding under her Riokay prefix. In 1987 Barbara was accepted into the Shorthair judges training programme with Queensland Feline Association and it was while she was studying the different shorthair breeds she decided to breed Abyssinians as well, as she found through watching the development of this breed from baby

kittens through to adults that they were very interesting and challenging with so many things to achieve to perfect what the standard required in an adult cat. Barbara has also bred and imported Somalis from Hawaii and held and experimental breeding program for Burmillas and Tonkinese and also bred Maine Coons for a couple of years. Barbara completed her training as a Longhair judge in 1991 and was elevated to the All Breeds Judges panel. Over the years Barbara has gained many major awards with her Burmese which are the love of her life, as well as numerous Supreme Exhibit winners in both Burmese and Abyssinians. In past years Barbara has had numerous Best Kitten and Cats of the Year with QFA and has twice proudly achieved Group 3 Prefix of the Year with QFA. Barbara has judged in all States and Territories of Australia and New Zealand on many occasions and has also judged in Kuala Lumpur, Germany and the Netherlands in 2011 and in South Africa in 2013. Barbara has held many positions within QFA since joining the cat fancy in 1984. First as a club Delegate to QFA then as Vice President for many years and then in 2002 elected as President of the QFA Inc. a position which she held until 2015 when she did not seek reelection. In 2017 Barbara returned as President until 2019. Barbara served as QFA President for a total of 15 years. She is currently President of the Gold Coast Cat Club and runs their show and is also President of the Burmese Cat Fanciers Club of Qld.



DAVID CRYMBLE (NZCF)

Being introduced in 1977 to the incomparable Siamese by a colleague, Christine Wright of Shadowfax Cattery fame, my lifelong feline addiction commenced in 1981 when I got my first prefix with NZCF. Thanks to Iris Kerridge, I was NZCF Siamese/Oriental Registrar for a short time in the '80's. Along my judging journey, I count myself extremely lucky to have been mentored by some of the best, in both SH and LH. Unfortunately, a good number of which are no longer with us. At differing times over the past 4 decades, (say it quickly and it doesn't seem so long ©) I have had the pleasure of breeding Siamese, Burmese, Russian, Abyssinian, Ocicat, Sphynx, La Perm, Selkirk and Bengal. During my LH training, I also bred Ragdolls.

In 2002, I was the first graduate of the Catz Inc. Judges programme as a SH judge and eventually became a SH Tutor Judge. In 2011 I qualified as a LH Judge.

In 2012 I was invited to join the Ancats Australia judges panel. I accepted as this allowed me earlier exposure to many more cat breeds than were currently available to Catz Inc. judges in NZ. (These were the early days in NZ when sharing of judges was still not allowed.)

I eventually became an All Breeds Tutor Judge with Ancats and for many years I was on the Ancats Breed Standards Committee. I was also very pleased to have been accepted as a WCF All Breeds Judge. Living now in Ngaruawahia, I am a member of Hamilton Cat Club and also on their Committee.

I still breed LaPerms and Munchkins, also their hybrid the Skookum.

I recently imported a Selkirk Rex female and a Lambkin female from Australia.

I love the dwarf breeds, which contrary to some opinion of many, is a healthy mutation to work with. Given the almost universal acceptance now of Australasian judges, I decided late in 2023 to apply to join and was accepted onto the NZCF judges panel



BELINDA PENGLIS (ACF - AUSTRALIA)

Belinda has successfully bred and shown Siamese and Orientals under the "Serendippidee" and "Diamante" prefixes since 1975, producing several Cat, Kitten and Neuter of the Year winners. She began Judging Group 2 in 1987, extending to Group 3 in 2006, and gained her All-Breeds Licence in 2008.

She has been an active member of Siamese and Shorthair Cat Club of Queensland since 1975 and is now a Life Member and Group 2 Tutor and Club President.

Away from cats, Belinda has a Ph.D. in Parasitology and is a Senior Veterinary Pathology Scientist. She also teaches Contemporary and Classical Ballet to professional level and in addition is a Mentor as well as a Practical Teaching Supervisor for the Royal Academy of Dance (London). Belinda also holds the Vice President position with Special Olympics Redlands.

She still gets an enormous buzz out of watching kittens grow and her philosophy has always been to breed well-balanced, healthy, happy kittens for people who love the Siamese and Oriental breed.

 Separate Top Ten placings will still be submitted to NZCF for National Awards and Titles.

Supreme Awards are calculated as follows:

10 points for BIS; 9 points for R/U BIS etc. Eligible exhibits MUST have won at least one BIS. Supreme exhibits will be decided by a judge's panel of one or more judges as follows:

- Top points scoring LH Entire cat & kitten, LH N/S cat & kitten (= supreme LH)
- Top points scoring SH Entire cat & kitten, SH N/S cat & kitten (= supreme SH)
- Top points scoring LH Dom, SH Dom, LH Com, SH Com (= supreme Dom/Com)

All Supreme winners MUST be photographed. All other exhibits must be available for photography if required.

There may also be a photographer on the show floor at any time during the show – by submitting your entries you consent that there is a chance you or your cats may be photographed

The club's new cages are the black wire cages and have NO solid back or sides.

We will provide loose dividers to place between the CABCC cage SIDES.

Exhibitors are encouraged to use their own cages.

You may bring your cages to the show on Show morning.

You will be allocated a space that fits a 76cm wide cage.

If your cage dimension is different and you need more space, you MUST indicate this on your entry form.

If you don't tell us you have a larger cage there may NOT be enough room in the show hall for us to change this on the day.

***** The Important Stuff *****

- 1. You must provide bedding for each of your exhibits. Coloured bedding and/or curtains may be used.
- 2. You may provide a white towel/mat on the top of your cage for judging. Please note that some judges will not use the towels, and this is at the judges' discretion.
- Please provide a litter tray for your exhibits (small plastic container the size of a shoe box is ideal). Wood pellet litter will be provided by the club.
- 4. All exhibits must be well groomed, have clean ears, be free from parasites (e.g. ringworm, fleas, mange) and MUST have their claws trimmed. PLEASE NOTE THAT FAILURE TO TRIM CLAWS MAY RESULT IN DISQUALIFICATION
- 5. Use of powders or aerosol sprays is prohibited in the show hall at all times.
- **6.** The age restriction for showing is 4 calendar months.
- 7. The age restriction for displaying kittens is 3 calendar months. The show committee will grant permission to have cats/kittens on display at their discretion, and no reason need be given for refusal to allow cats/kittens to be on display.
- 8. ALL kittens (whether being shown or on display) must hold a current vaccination certificate, showing a minimum of TWO vaccinations with the most recent vaccination being dated at least seven (7) days prior to the show.

 Please ensure you have your current vaccination certificate with you. Failure to present your kittens' vaccination certificates will result in disqualification of those exhibits.
- 9. A Veterinarian will examine all exhibits and display cats/kittens in their cages after Benching. Please wait until the vet has cleared your exhibit before leaving the Show Hall. The vet clearance will be clearly marked on your exhibits cage card only cleared exhibits may remain in the Show Hall. If your cat/kitten is vetted out it MUST be removed from the show hall.
- **10.** The committee may decline or accept any entry to the show, without giving any reason for such decision, and may at their discretion elect to accept any entry received after the stated closing date.
- 11. No refund of entry fees shall be given after close of entries. (NZCF Show Bylaw 4.6).
- **12.** No refund of overpaid entries shall be given.
- 13. All exhibits must be brought to the show secured inside a carry cage, NOT on leashes or in open arms. Failure to comply may result in disqualification of ALL your exhibits.
- 14. Carry cages must be left under your exhibition cages to facilitate evacuation of cats in the event of an emergency.
- **15.** Exhibits are not to be removed from the show without written permission from the show manager. If you need to leave early you must fill out the attached permission form (NZCF Show Bylaw 10.8). Forms may also be downloaded from the NZCF website. Removal of exhibits without permission may result in loss of all prizes and NZCF points.
- **16.** Please note that there may be club photographers present who may take photographs of you and/or your exhibits during the show. Entering the show constitutes acceptance that these photographs may be used by the club.
- 17. "For Sale" notices are NOT allowed on cages at any time and NO cats or kittens may be sold on show day within the confines of the show.
 - Promotional material may be placed on cages only after ALL judging (including supreme judging) is completed.
- 18. Domestic and Companion cats and kittens must be desexed
- 19. NZCF Show Bylaws section 8: No exhibitor shall exhibit a cat/kitten which to their knowledge has been exposed to any infectious or contagious disease/illness/parasite within a period of 21 clear days prior to the date of, and no cat shall be exhibited is the exhibitor has had such illness in his or her cattery during such period.
 - When any infection or contagious feline illness occurs within a cattery or household, then for 21 clear days after no further outbreak occur, or until a veterinarian certifies in writing that such illness is no longer contagious, no cat from that cattery or household shall be sold or exhibited.
 - Exhibitors having a veterinary certificate providing clearance from a contagious or infectious illness shall present the original dated certificate (no older than 14 days) to the Show Manager
 - Failure to comply with any part of this bylaw may involve disqualification for owners and their cats for such a period as the NZCF National Executive may decide.
- 20. Female cats which are obviously in kitten or lactating, male cats without both testicles palpable beyond the abdominal wall, and cats which have been declawed or devoiced shall be disqualified by either Veterinarian or Judge
