Top 10 awards will be made for both Longhair and Shorthair Pedigree Divisions in the following sections: Entire Cats, Entire Kittens, N/S Cats, N/S Kittens; as well as Domestic and Companion divisions in the following sections: Longhair, Shorthair.

NZCF Award Scoring

NZCF Award Scoring will be applied to all Top 10 Placings.

Breeders Award of Merit

A Breeders Award of Merit is offered by the NZCF Inc to the Breeder of the exhibit which, in the opinion of the Judge, is most worthy of the award. One Breeders Award of Merit will be offered in the Entire Cat section, the Entire Kitten section, the Neuter/Spay Cat section and the Neuter/Spay Kitten section.

Judging Top Tens and Supreme Awards

NZCF National Ring

Judging results for the National Ring shall not be disclosed to exhibitors or public at the time of judging.

A dedicated presentation and display cage area will be used for the National Ring Top Tens and Supreme Awards. Winning exhibits will be called up to this area. When called, please bring your cat, (use carry cage for safety if needed). Bedding in the presentation cage will be provided as part of the top ten prize for your cat (so don't bring bedding up to that area).

National Ring Top Ten exhibits are called up for award presentation only.

National Ring Supreme Exhibits are called up for both judging and award presentation.

The Longhair Pedigree, Shorthair Pedigree, Domestic, and Companion divisions will each have a NZCF Supreme Exhibit awarded, with these cats each gaining the title of National Supreme 2025.

There will also be an Overall National Ring Supreme Exhibit.

Method for National Supreme Awards: All National Ring Judges will confidentially pick their top cat from each of their Best in Show winners in each Section, and from these will decide the Supreme Award for each Division.

Method for Overall National Ring Supreme Exhibit: The winner will be determined from the National Supreme Recipients by mutual decision of the National Ring Judges.

Where a Division has more than one judge, the judges will collaborate to decide the winner

Auckland Club Rings 2, 3 & 4

Top Tens will be presented during judging.

The Longhair Pedigree, Shorthair Pedigree, Domestic, and Companion divisions will each have a Best Overall Exhibit Award.

The Best Overall Exhibit Awards will be announced, if timing allows exhibits will be called up for award presentation.

Method: All Ring 2-4 Judges will confidentially pick their top cat from each of their Best in Show winners in each Section, and from these the Judges Choice will be decided for each Division. Where a Division has more than one judge, the judges will collaborate to decide the winner.

There will be no overall Supreme for Rings 2-4.

JUDGES' PROFILES

Vicki Jo Harrison TICA - USA



My name is Vicki Jo Harrison, and I have been a cat lover my whole life!

I was born in the United Kingdom to US military parents but spent a large part of my childhood in the Far East and Hawaii. My love of cats began at an early age, when we acquired a Siamese cat, which traveled the world with us. After my father retired from the military, we settled in San Antonio Texas and that is where I still live today.

I began my "cat" career with a red point Siamese. After some constructive criticism and mentoring I got involved with a local club and began breeding Siamese and Oriental Shorthairs under the cattery name Radiance, which I still do today. I bred American Shorthairs for a very brief period, but the SI/OS are where my true passion lies. I have exhibited cats and kittens to both regional and international wins with the highest honor being Best International Alter in 2014 with LA IW SGC Radiance Rollin In The Deep, a blue-eyed white Oriental Shorthair neuter.

I am currently in my second term as President of The International Cat Association (TICA). I have been a member of the association since 1983. I was licensed in 1995 as a TICA judge and hold an Approved Allbreed Judge and Ring/School Instructor license which is the highest judging license that you can

attain in TICA. I am also a member of the Siamese Breed Group Committee. Along with the Siamese Breed Group Committee and other Siamese breeders from different associations around the world, I helped coordinate and manage the fundraising efforts for the ongoing research on amyloidosis in the Siamese group breeds.

In my non-cat life, I taught Kindergarten for 32 years before retiring in 2013 and then continued part time as an ESL (English as a Second Language) tutor until this past June. My husband, John and I were married for over 40 years until his passing in September of 2023.

Lorraine Shelton TICA – USA - Allbreeds



Internationally recognized expert in feline genetics

Cat Fancy related activities

Co-author, Robinson's Genetics for Cat Breeders and Veterinarians, The Original Cat Bible, and Royal Canin's Practical Guide to Cat Breeding. Authored The Guide to Owning a Tonkinese Cat (TFH), which received a Cat Writer's Association Award of Excellence. Author of numerous articles on breeds, feline health, genetics, and cat fancy history for various magazines, newsletters, books, and web sites.

Former Director of the Feline Historical Museum in Alliance OH and former board member of the Winn Feline Foundation (now the Everycat Health Foundation)

Lecturer in feline genetics for cat show events, TICA breed seminars, CFA breed council meetings, World Cat Congress seminars, and FIFe judging schools. Approved TICA Genetics Instructor and member of the Genetics Committee. Authored extensive revision to the TICA Uniform Color Descriptions in 2020 to reflect recent advances in feline genetics.

Consultant to the FIFe General Assembly in 2003 on the acceptance of the Scottish Fold and Munchkin breeds, new color acceptance, and management of the Bengal breed. Invited guest participant, UC Davis Feline Extravaganza 2003 and 2004, including private roundtable discussion on the genetic aspects of FIP.

As a foundation breeder of Selkirk Rex and Founding Vice-President of the first breed club, assisted in the writing of the original breed standard. Campaigned for the advancement of the breed to Championship status in associations around the world. Developed educational material on the genetics and physiology of this breed.

Registered Featherland cattery with CFA and TICA in 1988 to pursue the challenge of advancing the rare chocolate and lilac factored Persians. Bred first litter of pedigreed cats, Tonkinese, in 1972. Bred regional winning Turkish Angoras. Currently breeding national and international winning Norwegian Forest Cats.

Developed the Fanciershealth group with over 4000 members (now fanciers@groups.io) in 2000 to provide for the rapid and widespread distribution to cat breeders and rescue groups of recent advances in feline medicine.

Professional Background

B.S. in Biological Sciences, **B.A.** in Psychology (1984) University of California at Irvine.

Recipient, President's Undergraduate Fellowship for original research for immunology research. Elected to Alpha Epsilon Delta, pre-medical honor society.

Veterinary Technician (1986-1987) All Creatures Care Cottage, Costa Mesa California. Assisted in all aspects of the veterinary practice including surgery, treatment, and animal grooming. Developed in-house diagnostics lab for ELISA's, microscopy, hematology, urinalysis, and microbiology. Initiated and presented bi-monthly animal husbandry seminars for the public and authored client educational material.

Research Assistant, Animal Biotech Corporation (1987-1989). Developed veterinary immunodiagnostics, including the development of one of the first in-clinic FeLV ELISA test kits. Performed preliminary research on the development of an FIP ELISA test. Developed a program to certify catteries on-site as FeLV-free.

Scientist III, Baxter Biotech (1991-1996). Designed a rodent animal facility and ensured its compliance with all state and federal regulations. Responsibilities included performing survival surgeries, protein characterization (including mechanisms of degradation), therapeutic protein formulation development and evaluation, and the development of immunological, cytological, in vivo, and microbiological test systems.

Judges Training: Entering the NZCF Judges Training Programme and qualifying as Longhair Judge in 1981 extending my license to All Breeds in 1989. I get a great deal of satisfaction out of continuing to be involved with the Training Programme as an All Breeds Tutor.

International All Breeds Judging: I am honoured to be listed as a CFA Guest Judge and will continue to work towards becoming a CFA Approved Guest Judge. I thoroughly enjoy the judging scene, the forward thinking of exhibitors working with improvement of their chosen breeds and of course the interaction with exhibitors and cat lovers from all walks of life. I have judged in all Australian States, The Netherlands, South Africa, United Kingdom, USA, Thailand & China and will continue to share my knowledge "for the love of cats" with future exhibitors and breeders wherever this passion takes me.

GENERAL RULES, REGULATIONS AND INSTRUCTIONS

- 1. ALL KITTENS must be at least four (4) calendar months old on show day, and have had at least two vaccinations, 3-4 weeks apart with the last dose having been administered at least 48 hours before show day. (Must include cover for Feline Rhinotracheitis, Feline Calicivirus & Feline Panleukopaenia.). Vaccination Certificates must be produced before benching. Failure to produce a valid certificate will mean that your Exhibit is refused entry.
- 2. NO EXHIBITORS shall exhibit a cat/kitten which to their knowledge at the date of the show has been exposed to any infection or contagious illness within the period of twenty one (21) days or a period as specified by the NZCF Inc rules to the date of the show. No cat shall be exhibited if the exhibitor has had such illness in their cattery or household during that period. Any exhibitor, who in the opinion of the show committee, making a false declaration in respect of the above shall be liable to severe penalties under the powers of the National Executive of the NZCF Inc.
- 3. WITHDRAWAL OF ENTRIES See below under Show rules.
- 4. ALL EXHIBITS should be brought to the Show in cages and NOT in a blanket or on a lead. Exhibits are received at the Show only on condition that the Club should not be responsible for any loss or damage to cages etc. THE CLUB ACCEPTS NO RESPONSIBILITY FOR EXHIBITS BUT WILL ENDEAVOUR TO SEE THAT ALL CARE IS TAKEN.
- 5. ALL EXHIBITS must have clean ears, clipped claws (to prevent injury to handlers and judges) and coats free from ringworm, mange and fleas.
- 6. CAT LITTER will be supplied.
- 7. CLEAN BEDDING in the cage for each exhibit's comfort is a requirement, (exhibits that do not meet this requirement may not be judged). An unmarked toilet box, drinking water (recommended in a container fixed to the door) may be included.
- 8. VETTING At least one Veterinarian will be in attendance at the show and will examine each cat/kitten in its cage after benching. Exhibits may be lamped for ringworm. Please stay in sight of your cage/s in case the Vet has a query about your cat or kitten.
- 9. When your exhibit has been vetted, a coloured sticker will be placed on your exhibit's cage card. Only those exhibits cleared by the Vet may remain in the Show Hall. Any exhibit declared unfit for exhibition will receive a NZCF Veterinary Rejection Certificate and must be removed from the Hall immediately. The examining Veterinarian's written rejection is final. NO correspondence will be entered into.
- 10. No entry fees will be refunded for exhibits declared unfit by the examining Veterinarian/s on the day of the Show. If you have a Veterinary Certificate for any reason, show it to the Veterinarian and when your exhibit has been passed, you must then give the Veterinary Certificate to the Show Secretary.
- 11. In the event of unforeseeable illness before show day, where a certificate of illness from a Veterinarian is in the hands of the Show Secretary by 5:00 pm on the day prior to the show. Entry fees will be refunded less 25% for the bookwork involved.
- 12. Female cats which are obviously in kitten, or lactating, entire male cats or kittens without both testicles palpable beyond the stomach wall and cats or kittens which have been declawed or devoiced shall be disqualified by the Veterinarian/s, or a Judge and a Veterinary Rejection Certificate will be completed as in Bylaw 9.4.

- 13. CARRY CAGES must be stored underneath the show cages and any means of identification obscured prior to judging. This is to comply with Health and Safety precautions.
- 14. SALE OF KITTENS No exhibitor has permission to sell cats or kittens on Show Day within the confines of the venue or car park. Information can be provided at the Show.
- 15. PRIVACY ACT If you do not wish to have your name in the catalogue please specify on your entry form.
- 16. SUPREME EXHIBITS
- 17. National Supreme Awards: All National Ring Judges will confidentially pick their top cat from each of their Best in Show winners in each Section, and from these will decide the Supreme Award for each Division. Where a Division has more than one judge, the judges will collaborate to decide the winner.
- 18. Overall National Ring Supreme Exhibit: will be determined from the National Supreme division winners by mutual decision of the National Ring Judges.
- 19. Ring 2-4 Best Overall Exhibits (Best Longhair, Best Shorthair, Best Domestic, Best Companion): All Ring 2-4 Judges will confidentially pick their top cat from each of their Best in Show winners in each section, and from these the Judges Choice will decided for each Division. Where a Division has more than one judge, the judges will collaborate to decide the winner. There will not be an overall best exhibit or supreme in rings 2-4.
- 20. NZCF SHOW RULE 2.1 c. The Show Committee may decline to accept any entry or entries to the Show, without giving any reason for such decision, and may elect to accept any entry or entries arriving after the closing date stated.
- 21. NZCF SHOW RULE 2.1A The Show Committee may offer prizes as it decides, subject to the NZCF Show Bylaws, provided always that classes or prizes shall not be offered for progeny Sired by a specific cat, and free service from a stud cat shall not be offered as a prize.
- 22. NZCF SHOW RULE 2.1B Once this Show Schedule has been issued, classes or prizes shall not be added to, except for sweepstakes; and exhibits may only be entered in the classes for breeds, as published in the official Schedule of Breed Numbers.
- 23. NZCF SHOW RULE 3.4 (a) Any registered Cat exhibited at a show held pursuant to the Show Bylaws of the NZCF shall be entered in the Show in the name of its breeder or the person or persons to whom it has been transferred or leased, prior to the date of the Show, as exhibitor.
- 24. NZCF SHOW RULE 4.6 Upon written application to the Show Secretary, any exhibit may be withdrawn from any show with full fee refunds prior to the show entry closing date; and after that date with a possible forfeiture of part or all of the club entry fee, and all payment of the benching fees due to the NZCF.
 - NZCF SHOW RULE 10.8 Removal of an exhibit before the show has been officially closed without the prior permission of the Show Manager or Show Secretary will result in the loss of all club awards and NZCF annual awards points and any title points. For planned early departures, permission should be sought as soon as possible, and a minimum of 24 hours before the start of the show, using the Permission for Early Departure from a Show form. Emergency early departures still require the permission of the Show Manager or Show Secretary which should be recorded on the Permission for Early Departure from a Show form, which follows.

NOTES FOR NEW EXHIBITORS

Preparations Prior to show day:

Nails must be clipped, (all 4 paws) ideally prior to show day.

Vaccinations must be up to date.

Your cat must be treated for worms & fleas.

Your cat must be well groomed, flea free, in the best of health (and not pregnant!).

Cage furnishings – should be clean and not too bulky, should allow easy viewing & access to the cat.

On Show Day:

You must be at the show hall no later than 7.15am & you can't take your cat home until the show manager declares the show closed in the late afternoon No collars allowed to be worn at the show Refreshments for your cat – include food when judging is all done, water must be in a non-spill dish Interaction with the judges is fine, however do not in any way identify your cat to the judge unless judging has been completed and all awards announced.
